## **Terms and Conditions**

- 1. All parking charges, toll charges, passenger tax and road tax to be charged on actual basis. **excluding for package tours**
- 2. In case of transfers running over and above 55 Kms. will be charged extra as per agreed rates.
- 3. In case of full day local running in Delhi night charges will be applicable if the vehicle is used beyond 12 midnight. The rate would be Rs. 400 for 18, 27, 35, 41 and 45 seater and Rs 500 for Volvo and Mercedes coaches.
- 4. The tariff for Air conditioner coaches is worked-out on kilometers basis, therefore, Air Conditioning unit will not operate in stationery coach. For the comfort of tourists, only 10 minutes prior to the groups arrival, air conditioning unit will be switched-on.
- 5. For outstation tours, a minimum of 250 kms per day will be charged and is applicable for two days outstation or more.
- 6. Coaches will be parked in designated parking areas only.
- 7. All the invoices to be cleared within a maximum of 30 days from the date of submission of invoice.
- 8. Any coach used for marriage parties or similar functions, the above tariff will not be applicable and is subject to negotiation between the tour operators and transport operator. However, above rate will be applicable for all international and domestic conference and conventions.
- 9. GST is additionally charged as applicable.
- 10. Tariff is applicable with effect 1st January 2019
- 11. The tariff is subject to revision with a increase in fuel input cost by more than 5%. Today, diesel rate is Rs 72 per litre.
