Subject: Amendment to Chapter 2 – "e-Visa" of the Visa Manual

Sir,

Please refer to this Ministry's Circular no. 525 [No. 25022/102/2018-F.I] dated 22.01.2019 conveying certain amendments to Chapter 2- 'e-visa' of the Visa Manual.

2. Amendment conveyed to the note below para 2.5 of the Visa Manual [sub-para (C) of para 3 of this Ministry's Circular no. 525 dated 22.01.2019 referred to above] has been re-examined by the Government in the light of the stay stipulation period prescribed in para 2.5 of the Visa Manual for various sub-categories of e-visa. It has accordingly been decided, with the approval of the competent authority, to substitute the note below para 2.5 of the Visa Manual as follows:-

"Note the Immigration officer shall invariably put the stay stipulation period as mentioned in para 2.5 above on the e-visa".

3. All other provisions in Chapter 2 of the Visa Manual would remain unchanged and continue to be in effect.

These instructions shall come into force with immediate effect.
