Subject: Amendment to Chapter 2 - "e-Visa" of the Visa Manual

Sir.

Please refer to Chapter 2 – "e-Visa" of the Revised Visa Manual updated as on 15th September, 2017 and to this Ministry's Circulars no. 504 [F. no. 25020/75/2016-F I (Vol.IV)] dated 15th June, 2018 amending chapters 2 & 3 of the Visa Manual, no. 513 [F.No. 25022/46/2018-F.I] dated 10th August, 2018 and no. 522 [F.No. 25022/64/2018-F.I dated 20th November, 2018 amending various chapters, including Chapter 2, of the Visa Manual.

2. Keeping in view the huge popularity of e-visa regime among foreigners, the matter regarding further liberalization of the e-visa regime has been considered by the Government. It has accordingly been decided, with the approval of the competent authority, to increase the duration of e-Tourist and e-Business visas from the existing 60 days with double entry to 1 year with multiple entry subject to the stay stipulations and registration requirements applicable for normal Tourist and Business visas. In view of the decision to increase the duration of e-Tourist and e-Business visas, the existing provisions relating to extension of e-Tourist and e-Business visas within India have been deleted. Further, it has also been decided to remove the existing restriction that a foreigner can be allowed e-visa for a maximum of three times in a calendar year.

- 3 Accordingly, following amendments are made in Chapter 2 of the Visa Manual pertaining to e-visa:-
 - (A) Sub-para (i) of Para 2.5 is substituted by the following:-
 - For a period up to one year from the date of first entry into India with multiple entry on e-Tourist Visa and e-Business Visa, subject to the following conditions -
 - (a) On e-Tourist visa, continuous stay during each visit shall not exceed 90 days in case of nationals of all countries who are eligible for grant of e-visa except nationals of USA, UK, Canada and Japan. In the case of nationals of USA, UK, Canada and Japan, continuous stay during each visit shall not exceed 180 days. In all cases, no registration will be required.
 - On e-Business visa, continuous stay during each visit shall not exceed 180 days in case of nationals of all countries who are eligible for grant of e-visa and no registration will be required if the stay is for a period of less than 180 days. However, if the intention of the foreigner is to stay for more than 180 days, he/ she shall get himself/ herself registered with the FRRO/ FRO concerned within two weeks after the expiry of 180 days of his/ her arrival in India as provided in rule 7 of the Registration of Foreigners Rules, 1992. Further, the foreigner will also be required to register with the FRRO/ FRO concerned in case the aggregate stay in India on e-Business visa and/ or normal Business visa exceeds 180 days during a calendar year."
 - (B) Sub-para (v) of Para 2.5 is substituted by the following:-
 - "(v) In the case of e-Conference visa, extension may be granted for a maximum period of 30 days on case to case basis on merits of each case by the FRRO/ FRO concerned. Any further extension of e-Conference visa up to a total period of 180 days from the date of initial entry can be granted in exceptional cases on merits of each case only with prior approval of the Ministry of Home Affairs (Foreigners Division)."

(C) Note below para 2.5 is substituted by the following:-

"Note The Immigration officer shall invariably put the following unambiguous endorsement on an e-Visa: 'Stay not to exceed one year (in the case of e-Tourist visa & e-Business visa)/ 60 days (in the case of e-Medical visa and e-Medical Attendant visa) / 30 days (in the case of e-Conference visa) and registration not required'.

However, if the intention of the foreigner availing e-Business visa is to stay for more than 180 days, he/ she shall get himself/ herself registered with the FRRO/ FRO concerned within two weeks after the expiry of 180 days of his/ her arrival in India be required to register with the FRRO/ FRO concerned in case the aggregate stay in India on e-Business visa and/ or normal Business visa exceeds 180 days during a calendar year."

- (D) Para 2.8 shall stand deleted and existing paras 2.9 and 2.10 is renumbered as 2.8 and 2.9 respectively.
- 4. All other provisions in Chapter 2 of the Visa Manual would remain unchanged and continue to be in effect.
- 5 These instructions shall come into force with immediate effect.
