Subject: Implementation of e-Visa Scheme at Bhubaneswar Airport.

Sir,

In continuation of this Ministry's letter of even number dated 27.09.2018 (Circular No.517) on the subject noted above, I am directed to say that the proposal of extending entry to persons holding e-Visa at Bhubaneshwar airport has been examined by the Government. It has now been decided, with the approval of the competent authority, to include Bhubaneshwar airport in the list of entry points where persons holding e-Visa will be allowed to enter into India.

2. Accordingly, in paragraph 2.4 (1) of the Chapter 2 of the visa manual, following amendments are made:-
Replace 'and' by ',' before (26) and add 'and (27) Bhubaneshwar' after Madurai.
3. All other provisions in Chapter 2 of the revised Visa Manual would remain unchanged and continue to be in effect.
4. All authorities concerned are requested to strictly comply with the above mentioned guidelines.
5. These instructions shall come into force with immediate effect.
