**OFFICE MEMORANDUM**

**Sub: Sensitizing the stake holders on the subject of Mahan Travel & Tourism-reg.**

The undersigned is directed to inform that US Embassy in New Delhi has requested Government of India for making a demarche on the decision of the US Government to designate Mahan Travel and Tourism as Especially Designated Global Terrorist (SDGT) under E.O. 13224. Mahan Travel & Tourism is an affiliated entity of Mahan Air based out of Malaysia. Mahan Air is already designated by the US since October 2011 for providing financial, material and technological support to IRGC.

It is requested that the stake holders in Travel Trade/Hospitality Industry may desist from maintaining any relationship with Mahan Travel & Tourism. Any such relationship with Mahan Air and its affiliates may result in US sanctions.
